## STANDING ORDERS FOR COUNTY CONVENTION

In order that the proceedings of the Convention are carried out without delay, the following Standing Orders will be observed.

- 1. The proposer of a motion or an amendment thereto, may speak for three minutes, but not more than three minutes
- 2. The number of people entitled to speak and vote shall be in accordance with Rule 3.8 T.O.
- 3. A delegate speaking to a motion/proposal/resolution, or an amendment thereto, must not exceed two minutes.
- 4. The proposer of a motion/proposal/resolution, or amendment, may speak a second time, for two minutes, before a vote is taken, but no other delegate may speak a second time to the same motion or amendment.
- 5. The Chairperson may, at any time he considers a matter has been sufficiently discussed, call on a proposer for a reply and when this is given, a vote must be taken.
- 6. A delegate may with the consent of the Chairperson move "that the motion/proposal/resolution be now put", after which, when the proposer has spoken, a vote must be taken.
- 7. Standing Orders shall not be suspended for the purpose of considering any matter not on the agenda, except by the consent of a majority equal to two-thirds of those present and entitled to vote.
- 8. Delegates who refuse to abide by the Standing Orders will be referred to the Competitions Control Committee.

### FINANCIAL STATEMENT

Michael Casey, Byrne Casey & Associates confirmed that the Financial Statement for the 12-month period ended 30th September 2023, gave a true and fair view of the state of the assets, liabilities and financial position of Offaly GAA as at 30th September 2023.

An Cisteoir, Dervill Dolan provided a detailed explanation of all areas of income and expenditure for the year and in particular any variance between 2022 and 2023 figures. An Cisteoir, thanked everyone involved in Offaly GAA for their contribution to a very strong set of accounts for the year past.

The Financial Statement was adopted following a proposal from Peter Lyons (Drumcullen), which was seconded by Bill Kavanagh (Kilclonfert).

Ahead of Convention as per Offaly Bye Law 1.2 Christy Todd (Ballycommon), Nessa Feighery (Kilcormac/Killoughey) and Joe Cleary (Shinrone) indicated that they did not wish for their names to go forward for the positions of Assistant Secretary, Assistant Treasurer and Leinster Council Representative respectively.

There was an election for the position of Central Council Delegate and Michael Duignan defeated Dolores Slevin in the contest. There was also an election for the two positions on Leinster Council. Declan Ward (Crinkill) and Ciaran Groome (Bracknagh) were successful over Alex Roe (Clara).

On a proposal from Peter Lyons (Drumcullen) and seconded by Willie Forde (Edenderry) Brendan Minnock was appointed Planning & Training Officer.

On a proposal from Bill Kavanagh (Kilclonfert) and seconded by Willie Forde (Edenderry) Elaine Kelly Dunne was appointed Children's Officer.

On proposal from John Irwin (Birr) and seconded by Martin Ryan (Coolderry) the following Officers were appointed to attend Annual Congress; Michael Duignan, Colm Cummins, Dervill Dolan & Pat Teehan.

#### **CHAIRPERSON'S ADDRESS**

Cathaoirleach, Michael Ó Duigeannáin addressed the Convention and commenced by extending thanks to all volunteers, the Management Committee, Sub-Committees, Club Officers, and supporters for their cooperation during the year.

An Cathaoirleach outlined that one of the main pillars of the strategic plan was sustainable club coverage and in this regard the Chairman recognised that much improvement has taken place with facilities and club grounds in recent years and this is to be welcomed.

Further expanding on the strategic plan, the Chairman highlighted the vibrant games programme being managed within the county. There are now over 1500 games per annum. In addition, the schools and CnamB games programme adds additional layers of opportunities for our young players to participate in fixtures. There was particular thanks for Christy Todd and Carina Carroll for their hard work in administering the expanded fixtures programme.

The addition of full-time staff should ensure the successful delivery of the strategic plan and sustainability of its objectives into the future. The county was delighted to appoint John Hackett as the Head of Operations along with Carina Carrol as a full time Administrator. Adrian Clancy, Nigel Dunne and Gary Flannery make up the most senior staff members in coaching and games and they are supplemented by about 10 further games promotion staff. Significant appointments have also been made in the areas of Medical and Nutritional Services to your teams.

An Cathaoirleach proceeded to comment in the performances of our teams in 2023, how close the Hurlers came to capturing the Joe McDonagh Cup and the challenging season that our Senior Footballers experienced was offset by a great win over Meath at home. Our underage teams continued to perform well, and the highlight was a magical night in Carlow when we captured the U20 Leinster Hurling Title. He thanked all Management Teams for their efforts. The involvement of Offaly players at 3rd level was also recognised, with an increase in the number of players now participating at Fitzgibbon and Sigerson level.

In relation to finance, the Chairman outlined to delegates that when he became chairman in 2019, the board had the sum total of €670 in their own income and expenditure account but now have €416,000 at hand.

Gates income in 2019 was €359,000 and it was €516,000 in 2023, Sponsorship and fundraising in 2019 was €207,000, in 2023 it was €578,000 and Royalties from O'Neill's from the sale of jerseys was €30,000 in 2019 and double that at €60,000 in 2023. It was further outlined that the increased income was invested directly in our teams with spend across all levels up significantly.

He concluded by thanking the Management Committee and praised officers stepping down under the five-year rule, Paddy Scales and Dolores Slevin whose term as Central and Leinster Council delegate ended. He also mentioned assistant treasurer Nessa Feighery and assistant secretary Christy Todd who withdrew from their positions. He singled out Christy Todd for praise as someone who has given his life to Offaly GAA.

He ended on a note of reflection, by remembering all deceased members, mentioning Liam Kearns and former board chairman and Life President, Mr. Brendan Ward.

# **TUARASCÁIL AN RÚNAÍ 2024**

Following another very successful year for Offaly GAA, it gives me great pleasure to present my final annual report as Runaí Chontae Uíbh Fhailí to County Convention. This report is customarily an opportunity to reflect on the themes and events of the previous twelve months and highlight some likely topics for emphasis in the year ahead. Capturing the U20 Hurling All Ireland was a historic event, but the success in the Joe McDonagh Cup and resulting return to the Leinster Senior Championship remains very satisfying. We look ahead to the 2025 season with optimism and the added support of new full time staff and introduction of new Officers on the Management Committee. The aim will be to replicate the success of the last few years and provide some more great days for the Offaly Faithful.

The report covers three sections, firstly a brief synopsis of the year on the playing fields, secondly a commentary of the key administrative issues and finally some comments on our goals and objectives for 2025.

#### ON THE FIELD ACTIVITIES

It was an exceptionally condensed and busy year on the playing fields once again, but 2024 also brought much enjoyed success. Joe McDonagh Cup success for the Senior Hurlers, a big Championship win away to Laois for the Senior Footballers and the amazing All-Ireland win for U20 Hurling team were highlights that provided joy to all. In particular, a magical evening in Nowlan Park, Kilkenny winning the U20 title in glorious sunshine in front of a huge crowd of very enthusiastic Offaly Supporters, shall live long in the memory.

#### Senior Football

Notwithstanding a long-awaited defeat of Laois in the Provincial Championship, the Senior Footballers experienced a challenging year, which petered out with an inability to reach the knock-out stages of the Tailteann Cup.

After a win (v Laois) and a defeat (v Dublin) in the O'Byrne Cup, Offaly failed to gain a point from the first four rounds of the Allianz League, but two of those defeats, to Antrim and Clare, were both by a single point. Then, victories in Glenisk O'Connor Park over Wicklow and Limerick, either side of a draw away to Sligo, ensured we preserved our Division 3 status for another season.

The senior footballers reserved their best performance of the season for the Leinster Championship quarter-final versus Laois. After a blistering start, Offaly ran out convincing winners in Portlaoise by eight points. The reward was a semi-final meeting with Dublin at Croke Park and, true to form, the then reigning All-Ireland Champions advanced to the final once again.

Unfortunately, despite a determination to regroup, the results from the three games in the Tailteann Cup were disappointing and we failed to progress from our group.

Since then, Mickey Harte has joined the Senior Football

Similar to 2023, Offaly were left disappointed not to progress from their group in the Leinster U20 Championship, with just one win to show from their three outings.

The first round game, away to Louth on a horrible evening for football, resulted in a narrow two point defeat. Spirits were lifted when Offaly beat Kildare in a low-scoring but exciting game in the Faithful Fields.

However, the victory we required away to Longford failed to materialise as we had to settle for second best, by a single point on this occasion.

On reflection, we were not far off progressing to the knock-out stages, which would have been the target for this panel. Subsequently, Offaly entered the new All-Ireland competition for teams beaten early in the provincial championships, but we went down to Carlow by nine points.

We thank Ken Furlong and his management for their efforts with this panel over the past couple of years and wish new manager Mark Plunkett and his assistants all the best for 2025.

Even now, it is heartening to look forward to Offaly competing in the Leinster Senior Hurling Championship in 2025 and the buzz this should create in the county.

This is thanks to our pulsating victory over Laois in the Joe McDonagh Cup final at Croke Park last June, when our three point winning margin was greeted with both relief and elation.

Even though the Joe McDonagh Cup campaign began with a defeat away to Laois, the hard-earned success over Westmeath in Round 2 restored confidence in the camp and Meath, Kerry and Down were convincingly beaten in the following weeks, setting up a final where we made amends for the heartbreak of the 2023 final defeat to Carlow.

Earlier in the season, the vibes were positive during the Allianz League. Although there were no wins in Division 1A, performances against Wexford (a draw), Kilkenny and Clare, in particular, proved that Offaly were capable of competing at that level.

In their final game of 2024, the senior hurlers bowed out with their heads held high against Cork at Glenisk O'Connor Park in the All-Ireland Preliminary Quarter-Final.

Hopefully, the supporters will be out in force in 2025 to row in behind Johnny Kelly and the lads and help to ensure our steady progress in recent years will continue.

This group of hurlers deserve great credit for working their way back to the premier level of Hurling through hard work and dedication. It was not always glamorous but the players stuck to their task diligently and they got their reward. They have set a standard for our next group of players, that have experienced under-age successes ,and we look forward to a bright future.

to achieve this ambition and the ongoing refinements ensure we remain on track.

Our Development Squad model, under the tutelage of Adrian Clancy (Head of Games) and his Team, along with Carina Carroll (Coaching Officer) has fostered a focused approach and garnered strong support from players and parents. This model should be viewed in conjunction with the expansion of our games program and our ongoing collaboration with schools, which are fundamental to our new structure. While our approach may differ from other counties, we believe it best serves Offaly's unique needs.

It is crucial for everyone involved in Offaly GAA that every player enjoys their hurling and football experience. Being selected for an Offaly Development Squad is a significant milestone in a player's development journey. We aim to provide the best possible environment for players to flourish, recognising the efforts of our coaches, players, and the support of parents in raising squad standards.

The Faithful Fields is a vital component of the Development Squad experience. The exchange of ideas and relationships among coaches across all grades is invaluable, and the interaction among players of all ages fosters a strong sense of community within our county.

## **Players and Management**

I would like to take this opportunity to sincerely thank all of the Players, Management, Selectors and Back-room Teams for their outstanding dedication to the Faithful County. We are immensely proud of the manner in which you represented your County over the last twelve months and look forward to the season ahead.

#### Team Secretaries

It it certain that my role as County Secretary was made all the easier by the excellent support provided by our Team of Team Secretaries. As a dual county it would be impossible for the County Secretary to fulfil these duties for all teams. I have been lucky that dedicated volunteers such as Brendan Minnock (Senior Football), Dolores Slevin (Senior Hurling), Johnny Maloney (u20 Hurling), Ray Bell (U20 Football), Sean Doorley (Minor Hurling) and Niamh Slevin (Minor Football), carried out their duties so diligently and represented their county with such distinction at major games.

I wish to single out the work of Assistant Secretary, Brendan Minnock for his excellent work in the preparation of Official Team Sheets for all Offaly GAA fixtures. This is a huge task that must be completed with accuracy. Brendan's work in this area was flawless and a significant help to me as County Secretary.

### **Club Championships**

The CCC led by James Murphy and Pat Teehan met 18 times in 2024 to ensure the smooth running of both adult and under-age games programmes. With the support of a committed team of referees and clubs they delivered an ever expanding programme of games.

Growing and sustaining a vibrant games programme is critical to the development of both codes in Offaly. Our players at adult and under-age level need a consistent games programme that provides opportunities to grow and develop with certainty around scheduling. Much has been achieved in recent years expanding the under-age games programme but our adult competitions have contracted in the same period. The changes at national level and introduction of the split season and the demands of provincial competitions on the other end of the season has resulted in a very narrow window for a dual county like Offaly to deliver a robust games programme. It must be acknowledged that Leinster Council worked hard to tighten its Provincial Club Programme in order to provide Counties with more weeks for internal games.

Furthermore, a culture has developed within our own county over many years that once a side exits the championship their season is over. In this regard we are an outlier, as most counties run extensive league programmes that run from March to October and provide the club player with an extensive programme of games. Expanding our adult playing season along the lines of our under-age games programme will provide more games for our players to develop and also greatly improve the games to training ratio.

In the early part of the year the restructured football championships caused some disquiet but once the respective campaigns commenced and proceeded to knock-out stages it was largely forgotten. However, the 2024 review has left the door open for an expansion to our Senior Football Championship. Hopefully this opportunity is seized as Club's should be striving to play at the top level always.

Congratulations to all the teams that participated in all Championships and Competitions and particularly to the winners at all levels. Collecting the silverware can make all the efforts worthwhile but there are always runners-up and clubs should be very proud of the levels of participation being achieved. Walk-overs are always

unwelcome and this year 7% of the games at adult level and 5% at under-age resulted in walk-overs.

All Offaly Teams acquitted themselves very well in the Leinster Club Championships, with KK narrowly defeated in the Leinster Final but Ballinagar captured the Leinster Junior Title. Congratulations to all clubs that represented Offaly in these competitions this year.

## **ADMINISTRATION**

In 2024, we returned to a pre-covid model of holding meetings in person, however we used online methods when required and going forward a hybrid model will probably work best.

This year we continued to build on the significant Governance Audit work completed in 2022 & 2023. We endeavoured to implement the recommendations of the audit putting procedures in place for the county.

Overall our systems are considered robust and some updated policies will be implemented in early 2025 once further guidance is received from Croke Park.

As we move forward, we will continue to improve the administration function and capacity of the County. Our aim is to ease the burden for Club Officers, who give so much to the Association and assist new Officers moving into roles with their clubs.

I would like to take this opportunity to recognise the efforts on the Offaly GAA Management Committee and their work for the County throughout the year. The detailed reports set out in the Sub-Committee Reports section of this document are testament to the hard work carried out in 2024.

### **HR & Full Time Appointments**

In 2023, Offaly was very fortunate with the full time appointments made in Head of Operations, Head of Games and the Administrator Role. The stability provided by our three full-time Leaders, John, Adrian & Carina is critical to the improved operation of Offaly GAA.

Their energy when combined with an excellent Coaching & Games Staff will lead the County on the journey it needs to travel, guided by elected officers on an annual basis.

Along with Club GPO staff in the County, We now find ourselves in a very strong position with the personnel at our disposal. There is a very clear vision for the delivery of a high performance programme for the county along with a robust support structure for our clubs. This is paramount to deliver of our core objective of providing a player centred experience in Offaly GAA.

Our team of full-time staff shall ensure on-going review and implementation of our Strategy over the coming years. This will provide the consistency in approach to deliver on our goals in a meaningful way and establish our county as a force in both codes once again.

### **Coaching & Games**

Our new Coaching & Games staff model combined with an energised Coaching & Games Committee ensures that the county is continually striving to improve playing standards across the county. Working closely with Coiste na Óg, an expanded and robust games programme has been delivered and this forms a critical element for the growth and improvement of standards across the county for our young players.

Our reorganised Development Squad model has proven very successful in providing an outlet to nurture elite performance. There is a strong desire among our young players to be involved and this is a credit to the work of Coaching and Games and the coaches involved.

It is worth noting that many Clubs continue to strive towards best practice in relation to Coaching and Games and it was positive to see clubs initiate Nursery Programmes in 2024. Work will continue in 2025 to encourage the best standards in club coaching. We are encouraging clubs to embrace the opportunities offered by the small sided Go Games Programme to enter teams as individual clubs as opposed to Independent Teams.

## Go Games Programme 2024 & Beyond

The Club is the basic unit of the Association, and its objective shall be the promotion at local level of the Association's aims, as stated in the Official Guide. In a predominately rural county, where some clubs do and will continue to play as Independent Teams at competitive age grades in order to field teams, the Go Games Model offers the opportunity to foster the sense of club from an early age. In 2024, we tried to encourage clubs to field U8 & U10 teams representing their own club, especially as games at U8 can be 5-a-side. Unfortunately, this initiative was not embraced by some clubs.

We feel this is a missed opportunity. It may be the case that the message around this initiative was misunderstood by some clubs that didn't recognise the potential benefits. Offaly Coaching & Games and the Management Committee of Offaly GAA firmly believe the vast majority of Clubs should field under their own colours at U8 & U10 level. The benefits and positivity such an initiative can bring to clubs would be immeasurable. It is imperative for Offaly GAA that our clubs remain vibrant and central to their community. Providing children and families local to your own club with the opportunity to have their first GAA experience in your very own club

colours is the essence of the GAA. One of the main pillars of the Offaly GAA Strategic Plan is 'Sustainable Club Coverage' - our Go Games ambitions are central to delivering on the aforementioned objective and providing clubs with the opportunity to deliver a positive first impression.

A further benefit of clubs embracing this initiative would be a more varied games programme within smaller geographic areas. The cornerstone of this strategy is to grow the games, be more inclusive, make the games more accessible whilst optimising fun, friendship, fairplay and enjoyment.

Our Demographics Officer, Paul Rouse, continues to conduct research in this area and the ambition to have every club field on their own at Go Games level will be revisited again. However, we acknowledge that 'buy-in' from each club is key. This should be seen as an opportunity for each club and not a threat.

I would call on Club Chairpersons and Club Secretaries to have greater involvement with under-age teams - as a Senior GAA Leader in your community you must be directly involved in under-age activities and you should ensure that your club is participating on their own in Go Games.

#### Football Review Committee

In my report last year I called out the poor state of Gaelic Football. As custodians of Gaelic Games I believe we have a collective responsibility to protect our games and ensure that they are passed to the next generation in better condition than we received them. Whilst the argument will be made that the game evolves with each generation, I contend we should be very careful not to allow the game to evolve too far from its original principles.

The origins of the GAA are based in the fact that we wished to protect our indigenous games from the influences of foreign or alien games. At the foundation of the GAA, Archbishop Croke described Hurling and Football as games 'racy of the soil' and forming 'manly exercises' in comparison to imported field sports of the time. I pose the question, are we now importing coaching methods, statistical measures and game plans designed for other games to the overall detriment of our own games.

In this regard, I welcome the proposals of the Football Review Committee, under the Chairmanship of Jim Gavin. They have been thorough in their work and have presented proposals that are radical enough to ensure that coaches and players must return to the true values of the games.

Special Congress has provided the opportunity to implement the rules for one year. This is welcomed as failing to do so would result in patrons voting with their feet, falling attendances and falling revenues. The current levels of investment in our games could not be sustained in that scenario. Already there are trends toward lower attendances at National, Provincial and Club level.

Underpinning falling attendances with additional games and competitions shall not solve the problem. We should embrace the rule changes and not be afraid to call out coaching and negative play that deviates from the original principles of the game. We need to monitor the situation very closely.

#### **Match Ticketing**

Over the past couple of seasons we have moved to online ticketing for the vast majority of our fixtures. This has proved extremely successful and I wish to recognise the work of our Finance Committee and our Treasurer's Dervill Dolan and Katie McLoughlin for their commitment to the success of the project. In addition, I would like to thank all the volunteers that operate gates for the County on a regular basis and to the Clubs for their support with the transition to cashless games. Issues in relation to access to ticketing systems, particularly for older generations was acknowledged in 2024 and a Season Pass solution for OAP's was developed that helped alleviate those concerns.

However, it is important that we do not get complacent and Clubs are encouraged to ensure that the standards in relation to online ticketing are upheld even for games lower down the grades.

## Glenisk O'Connor Park & Faithful Fields

Throughout 2024, both Glenisk O'Connor Park and Faithful Fields witnessed huge levels of activity. For the first time in a few years we hosted some big Inter-County fixtures including the Double Header between Tyrone v Cork (F) and Offaly v Cork (H). The Grounds staff at both locations should be suitably proud of how the grounds were presented at all times.

### Sponsorship & Fundraising

In 2024, we were delighted to continue our Sponsorship Partnership with Glenisk. Their overall contribution to Offaly, represents a major opportunity to progress Gaelic Games in the County. It offers financial stability

and the resources to implement our ambitious plans for the future. The sales for the Offaly Jersey carrying the Glenisk logo have been very high to date, with a new design for the alternative jersey being released ahead of the 2025 season.

We were also delighted to continue with Galvin's Tullamore on the sleeve of the Offaly Jersey in 2024. This well known and popular brand is an excellent fit with Offaly GAA.

Again, in 2024, Molloy Environmental & the Tullamore Court Hotel provided sponsorship for our Senior Hurling & Football Championships along with EJ Access Solutions as sponsor of our under-age championships. These are very important partnerships for the County.

We are delighted that our partnership with Shane Lowry continues. Shane is a wonderful ambassador for the County and role model for our players.

Given the growth and success of the games in the county Offaly GAA were extremely pleased to announce the significant sponsorship of Condron Concrete of Offaly Coaching and Games for 2024/2025. In recognition of the aforementioned expansion of staff and activities, the substantial funding from Condron Concrete allows Offaly GAA to continue our ambitious coaching & games programme.

We continue to grow our pitch side sponsors at Glenisk O'Connor Park, with many new partners coming on board in 2024.

Offaly GAA has worked hard over the past five years cultivating successful partnerships with all of the above companies. The mutual respect and understanding of the goals and objectives of the county has allowed the partnerships to flourish. In this regard, it was with great pleasure that, we were able to announce five year extensions to the above partnerships at our recent County Committee Meeting. We look forward to many years of continued partnership.

I would also like to acknowledge the work and commitment of Club Faithful over many years. Thanks to the Offaly Association in Dublin for their contribution in 2024 through their very successful Golf Classic held to support Offaly GAA.

#### **Club Support**

Offaly GAA can only ever be the sum of its parts and in this regard the 41 Clubs of Offaly are important cogs in

the machine. Without the army of volunteers in each and every club, the GAA would not exist and would not operate successfully. Every volunteer can be very proud of their contributions.

It is important that Offaly GAA continues to work in partnership with our Clubs and Volunteers in the year ahead to continue the drive towards on-going success for our County. Sustaining high performance for our County teams can only be achieved through the development of our players at Club level. Therefore it is imperative that each Club strives to raise their own standards and the Officers of the County Board are here to assist in this regard.

I would like to express thanks to the Clubs of Offaly for aligning their respective Financial Year and AGM timetable to meet the requirements of the latest rule changes. Consistency on timing of administration issues like the above will allow us to further streamline administrative processes and improve preparations for the year ahead.

#### Scór Sinsir

I would like to acknowledge the work of Michelle Hogan and the Cultural Committee and their promotion of Scór in 2024 and over the past five years. Michelle has fulfilled her duties very diligently and was a great ambassador for Offaly GAA. Offaly Clubs were well represented in Leinster and National competitions.

## In Memoriam

Over the past 12 months Offaly GAA suffered the loss of former County Board Officers, Players and Club Officers. In April, the death of former County Board Chairman, Mr Ollie Daly was announced. Although Ollie had lived a long and fruitful life, there was huge sadness at his passing for he had been such a great Gael and ambassador for his county.

Just weeks ago Offaly GAA was very sad to mourn the passing of Bill Kavanagh. Bill was a very committed and hard-working Gael for both Club and County.

Last December there was a huge out pouring of grief for the very popular Johnny Flaherty. Kinnitty came to a standstill just before Christmas as it laid one of its most famous sons to rest.

Former Players, County Board and Club Officials passed away during the course of the year John Flanagan (Tullamore), Brendan Martin (Tullamore), James Dooley (Drumcullen), Ger Connolly (Bracknagh), Thomas Kelly (Banagher), Peter Masterson (Rhode), Willie Dooley (Seir

## **LOOKING AHEAD - 2025 & BEYOND**

This is my final report as Rúnaí Coiste Chontae Uíbh Fhailí. I have completed four years as Secretary and one year before my appointment as Planning & Training Officer. Although is has been a very busy five years, I have thoroughly enjoyed my time with Offaly GAA.

I was central to the development of the strategy developed for the County in 2020 'The Offaly Way Forward'. The strategy served our administration well over the last number of years. The principles of the plan have guided the work of the Management Committee and all of the Sub-Committees operating under the auspices of Offaly GAA. Striving towards the delivery of the key goals and objectives of the plan has established a solid platform to allow the county to excel. The central theme of the plan is our player centred approach - as we move forward it will be important not to deviate from this or get distracted by side issues. We are here to improve the games and grow the GAA in the county.

An important element of the consistent implementation relies on the appointment of a dedicated team of full time staff. The experienced and energised group we now have in place will continue the incremental improvement of the county through aligned annual operation plans. This structure is essential to ensure Offaly GAA remains on the pathway to returning to the highest levels of competition. The recent successes of our under-age teams proves that Offaly can dine at the top table once again. We must ensure we are prepared and organised to capitalise on our ambition.

As new Officers take up their positions following Convention it would be a worthwhile exercise to complete a review of the plan and develop a new strategy for the next period. This would facilitate the further development of the five pillars of the existing plan, that will ensure the continued delivery of the goal of an 'Unrivalled GAA Experience' in County Offaly. The five pillars can be further refined in 2025, as specific projects are identified for implementation.

### 1. Sustainable Club Coverage

A sustainable network of Clubs providing positive entry points to the Gaelic Games family by maximising participation & provision of excellent facilities

#### 2. Vibrant Games Programme

A defined calendar of games via Club & Schools providing meaningful participation for all levels

## 3. High Performance Pathway

Provide clear pathway for high performers to excel at County level

## 4. Financial Stability

Our Clubs and County Board are financially stable with robust governance procedures in place

## 5. Respected Brand

The Offaly brand is synonymous with success and excellence

On reflection, 2024 was a very positive year on the field of play, particularly on the hurling fields. The U20 All-Ireland win in Nowlan Park and obvious highlight, with the Joe McDonagh win an important step too. The intensity of the split season is very challenging for a dual county and the sheer number of games in a condensed period amplifies the efforts required to maintain a true dual county. We feel those substantial efforts should be very clearly reflected in the funding model allocated nationally to each county and this is an area that we shall be perusing in the coming year.

Following recent under-age success in both codes, there can be an expectation that our adult teams should automatically improve. However, patience will be required in order to develop and nurture our emerging talent. There is a body of work to be completed to bring our developing players through and be ready to make an impact at Senior level. Our ambition is to bring ourselves back to the top level in both codes and importantly sustain our position at that level.

The U20 Hurlers were certainly the stand out team of the year and brought All-Ireland glory once again. Many of these players are under-age again this year and this brings an expectation that we will compete for honours again this year.

Finally I would like to thank everyone who helped me in my role as County Secretary. I have received wonderful support from volunteers across the County, my colleagues on the Management Committee, Leinster Council and from Croke Park full time staff.

In particular, I would like to thank my fellow Officers Michael Duignan & Dervill Dolan for their hard work dedication and commitment to Offaly GAA.

Five years ago, the three of us set out on a journey with the simple ambition of improving the fortunes of Offaly GAA. As we step way from our current roles, we are satisfied that the structures now in place, provide a solid foundation and a new belief has been instilled to ensure Offaly teams can compete at the highest levels in the years ahead.

The Finance Committee for 2024 comprised Mark Gorman (Chair), Dervill Dolan (Treasurer), Paul Craven, Padraig Egan, Tony Flanagan, Aiden O Neill, Paddy Scales and Katie McLoughlin (Assistant Treasurer). The committee was supported by our Operations Manager, John Hackett, and we thank John for all his work and support throughout the year.

Offaly GAA recorded a surplus of €16,908 for the year ended 30th September, 2024. While Income has increased during the year, we have also seen an increase in our spend which will have to monitored carefully as we go forward.

The detailed audited financial statements for 2024 are attached with this report.

Some of the key movements in the financial accounts for 2023 include the following;

 Gross gate income for our 2024 Leagues and Championships was €543,957 compared to €516,870 in 2023. This represents an increase for 2024 of €27,087 or 5.24% year on year. Our Hurling gate income increased by 1.2% while our Football gate income increased by 10.2% primarily due to extra football matches in 2024.

- A new financial structure was introduced in 2023 to support our Games Development and Coaching. The total income receivable in 2024 from Central Council, Leinster GAA and Club contributions was €441,850 (2023 €347,451), while the total Coaching and Games Development costs were €504,918 (2023 €399,649). This new grant support structure has allowed Offaly GAA and our clubs increase the number of coaching staff in 2024 to 13 coaches at present.
- The Cúl Camp surplus of €46,333 (2023 €49,085) represents a significant contribution towards our Coaching and Games Development costs again this year.
- As a result of our Senior Hurlers winning the Joe McDonagh Cup final in 2024, Offaly GAA received a County/Holiday Grant of €100,000. The Senior Hurling panel travelled to Tenerife for the team holiday in December, 2024, at a cost of €91,600.
- The County Team Administration costs of €1,373,730 represents a significant expense for Offaly GAA and an increase of €212,876 on the 2023 spend. While €91,600 of this increase represents a team holiday expense, our catering/ food and medical/physiotherapy costs have also increased. We must continue to focus on managing these costs while ensuring we continue to provide quality facilities and good supports for all our teams and development players.
- The O' Connor Park Income and Expenditure Account reflects a surplus of €22,024 in 2024 (2023 Deficit of €25,125) and a surplus of €68,007 after adjusting for non-cash items (2023 €24,743 surplus). The surplus in 2024 arises primarily due to an increase in signage income and a reduction in maintenance/upkeep costs.

The Balance Sheet at 30th September 2024 shows an improved position on last year as a result of the surplus for the year with an Accumulated Fund Surplus of €559,914 compared to €543,006 in 2023.

The OCP redevelopment loan balance has reduced by €110,079 from €1,249,062 in September 2023 to

€1,138,983 in September 2024.

While the financial position of Offaly GAA has improved in recent years, it is very important that we continue to focus on improving all our income streams while also ensuring that all expenditure is managed efficiently. A continuing strategic approach to investing in our teams and our facilities with good governance and oversight will help put our Clubs and County in the best position to achieve success with our teams into the future.

We are very grateful to all our sponsors and to all the people who supported our fundraising initiatives and contributed to Offaly GAA during the year. The Universe ticketing system is now fully operational for our games and provides greater control and security managing our gate income.

A word of thanks to the Offaly GAA Management Committee for all their support. Again, members of Management did not claim honoraria and other expenses this year. Thanks also to Leinster Council and Central Council for their support throughout the year.

On the field of play, both our U20 Hurlers and Senior Hurlers brought great joy and excitement to our County in 2024 with the fantastic success of our U20 Hurlers winning the Leinster and All-Ireland finals and our Senior Hurlers winning the Joe McDonagh Cup Final and taking our Senior Team back into the Leinster Championship for 2025.

Thanks to everyone involved with our teams, our clubs, our sponsors, all our volunteers and supporters and to everyone who has contributed to our success both on and off the field in 2024. A word of thanks also to the members of our Finance Committee for all their help and assistance.

The Committee held 18 meetings during the year 7 of which were on-line.

## League & Championship

The 2024 adult championships proceeded in accordance with the approved Fixture Calendar, with the exception of the Junior B football championship, which concluded slightly later than scheduled, due to a successful objection at quarter-final stage. The U20 Hurling and Football Championships, which did not commence until October, are now at concluding stages. The Adult Hurling and Football Leagues were completed prior to the commencement of the 2024 Club Championship Programme.

## Review

During 2024 a committee was established to review the Championship structures for 2024. This committee comprised of James Murphy (Rhode), Pat Teehan (Coolderry), Eoghan Maher (Ballyskenagh/Killavilla), Colin Hanlon (Gracefield), Leo Dempsey (Clonbullogue), Tony Dalton (Clara), Eamonn Dunican (Erin Rovers), Paul Craven (Kilcormac/Killoughey), Brendan Minnock (Shamrocks), Brian Flynn (Ferbane), Paul Rouse (Tullamore). Final recommendations in relation to all Championship structures for 2025, will be made when club gradings are complete.

Concern continues to be expressed at the lack of competitiveness in the League Competitions due, in the main, to the non-involvement of Inter-County panellists.

Clubs are currently being asked to express their opinions in relation to the structure of the Leagues for 2025 and a decision will be made in the New Year, by the County Committee, following a recommendation from the above Committee.

#### Walk-Overs

While walk overs still remain an issue in the lower grades of League and Championship, 2024 has seen an improvement, particularly in the Championship. There

were 35 walk-overs (15 in hurling and 20 in football) conceded in the Hurling and Football Leagues, 28 of these were in Division 4 & 5 of the Hurling and Football leagues. Clubs should give serious consideration, before entering second and third teams in the league.

On a more positive note the number of walk-overs conceded in the Championship reduced from 29 in 2023 to just 10 in 2024. The main reasons, for this, were two-fold, Clubs not being asked to confirm entries for Junior B & C Championships until the end of April and the decision to play the Junior B & C, Championship group stages on a regional basis.

#### U20

For 2024 it was decided to play the U20 Hurling and Football Championships, commencing in late October and while we are now at the concluding stages of both Championships, it is not an ideal time, with a crossover of School and College games, Provincial Club Championships, and players away in College. The timing and format of the Championship, for 2025, will be reviewed by the Fixtures Review Committee.

## Under-Age

The Offaly Under-age Games Hurling & Football Programme had a very active and comprehensive season with various leagues, competitions & games from March to November, and in excess of 1,000 games being played. In all 34 games were conceded (an increase of 4 on 2023), but it's still an achievement to ensure that all boys from U8 to Minor had the opportunity to play at least 9 matches in one code or 18 dual matches in 2023. Sincere thanks to host clubs for their contribution to this successful season.

## Discipline

Of the almost 1,300 adult and under-age games played (not including games played at U11 and below) infractions (Players & Team Officials) were reported in 117, that is down from 168 in 2023. Of the 83 Disciplinary Notices issued (not including 34 for 2 yellow cards), 10 sought hearings, of which 3 had their penalty reduced or rescinded.

The main source of concern is that, while the number of incidents of players reported for abuse of referees is down to just six, it is still six too many. Unfortunately, we still have team officials and supporters abusing and threatening match officials and this is totally unacceptable. The fact that we had 12 such cases at under-age level is all the more concerning. Clubs need to face up to their responsibility in this regard and remove such

individuals from being part of any team management.

### Parish Rule

In the last number of years the CCC has had a number of cases to deal with, in relation to transfers and first club membership, conflicting with the Parish Rule. These are issues, particularly in the case of young boys, that can prove very sensitive and difficult, but the CCC have a responsibility to make their decision within the parameters of Rules and Bye-laws, and must act accordingly.

The Parish Rule (including Catchment areas within Parishes) has served this County well and while it remains in force it is incumbent on everyone to ensure it is adhered to. In this regard all clubs have an obligation to abide by County Bye-laws and Codes and Rules in the Official Guide.

#### **Thanks**

A sincere thank you to all referees who officiated at games during 2024. Thanks also to the members of the Referee's Administration Committee, for their work in recruiting and training referees. The co-operation and support of clubs, players, referees, Sub-Committees

and County Committee during 2024 was very much appreciated by the Competitions Control Committee.

Club venues throughout Offaly are of a very high standard and clubs deserve credit for the ongoing developments and improvements.

Thankfully the weather was kind to us in 2024 and only a hand full of games had to be postponed due to the weather.

Sincere thanks to all members of the Competitions Control Committee for their commitment in 2024.

# Coiste Éisteachta

As per the Treoraí Oifigúil, the function of the Hearings Committee is to "adjudicate on all disciplinary matters where a hearing is prescribed and requested, relating to the enforcement of rules arising from matters under the jurisdiction of the county committee or the executive committee of a club within the county."

The County Hearings Committee does not seek to be seen as a defender of referees, committees or players and assesses the evidence put before it in a fair and impartial manner. Depending on the specific circumstances of each case and the evidence presented, the members of the committee are sometimes left with difficult decisions to make and must strive at all times to be fair and objective in arriving at their decision, while complying with the Treoraí Oifigúil.

During the course of 2024, an Coiste Éisteachta dealt with three appeals and eighteen requests for Hearings. All three appeals were deemed to be lost and were subsequently appealed to Leinster Hearings, where they were also deemed lost. While initial moves were made to take these cases to the DRA, the clubs involved reached agreement and didn't proceed to DRA.

Regarding Hearings requested, one was withdrawn and two were deemed out of order as they didn't comply with required procedures. Two red cards were rescinded based on video evidence and a further red card was rescinded based on a procedural matter which had compromised the player's right to a fair hearing.

Twelve suspensions were imposed, eleven based on evidence presented and one based on the defending party not turning up on time for the hearing. Seven of the twelve suspensions were appealed to Leinster, but did not succeed there, with three of those subsequently being lost at Central Hearings also.

Two hearings are pending at time of writing.

Where any member or unit is not satisfied with a decision by the Hearings Committee, they have the right of appeal to the Leinster Hearings Committee. It is important to note that a successful appeal hinges on demonstrating that the decision maker infringed or misapplied a rule – it is **not** a re-hearing.

The Official Guides and Codes are available on the GAA website and once again, the committee urges members to familiarise themselves with the contents of all relevant publications and ensure documentation is in order.

Thank to our referees for clearly stating infractions on reports, club secretaries for their timely and responsive communications, and to all who attended Hearings throughout the year for their courtesy and conduct. Thanks to the members of the CCC who represented that committee at meetings. Finally, thanks to all members of An Coiste Éisteachta for the time and commitment in their efforts to ensure that all Appellants received a fair hearing.

Finally, to end on a very sad note the Hearings Committee lost one of its most respected members recently, the late Bill Kavanagh from the Kilclonfert Club. Bill was a member of the Hearings Committee for a number years and his relaxed and practical approach to cases that came before the committee will be sadly missed. Bill always had a smile on his face and was more than happy to play devil's advocate when cases were being discussed at the end of the Hearing.

The Hearings Committee would like to extend our sincere sympathy to Bill's family and the Kilclonfert Club.

A lot of work was undertaken behind the scenes in January as final preparations were made by Club Reps and Coaching & Games staff to finalise the 2024 pack, which covered all games and plans from Nursery to Minor. This is an important document for all Clubs and families as it allows early planning for the year ahead. All guidelines and rules are also included in the pack and it is an excellent guide for Coaches and parents. The pack was issued on the 1st February.

The first meeting of the year took place in Glenisk O'Connor Park on the 15th February with Coiste na nOq Club representatives in attendance. County Chairman Michael Duignan opened the meeting and welcomed the large crowd. He addressed the issue of Independent Teams and asked Clubs at the very least to make a concerted effort to develop a Nursery in their Clubs and start to build from there with a view to entering U8/U10 Go Games teams. He also highlighted the importance of children being able to identify with their own Club colours. The Chairperson referenced the fantastic facilities we have in Faithful Fields and the positive plans afoot with our Player Pathway and again encouraged each and everyone to continue to get behind our County Teams on match days. Coaching and Games Chairperson Carina Carroll then gave an overview of the plans for 2024 for Nursery to Minor and the Games Development officers gave an overview of plans for Development Squads and coaching officers roles within the County.

#### **Fixtures Calendar**

By the end of March all Clubs were up and running with fixtures and games programmes and so a busy season commenced. On 20th May Coiste na nOg /Coaching and Games held a mid-season review to get some feedback from Clubs on how the plan for the year was progressing and any issues which were arising. A good meeting took place with issues teased out and positives noted.

## **Feile Competitions**

Feile football competitions were held over the weekend of 9th March with Tullamore running out Division 1 winners and Gracefield winning the Division 2. Feile hurling took place on the weekend of 23rd March with Birr crowned Division 1 winners and St Rynaghs running out Divisions 2 winners.

In June our Feile Hurling winners headed off to represent Offaly, with Birr travelling to Wexford and winning out their Division and St Rynagh;s travelling to Rosenalis in Laois and unfortunately losing out to St Lachtains of Kilkenny in their final. Our Feile football winners Tullam-

ore headed to Roscommon and Gracefield travelled to Louth, but unfortunately neither Club came away with any silverware. Many thanks to the four Clubs who represented their Clubs and County with such pride and passion and thanks to the committed coaches and parents for their continued support and encouragement.

## **Shane Lowry Leagues**

August/ September saw the completion of the Shane Lowry Leagues for our U12 Hurlers and Footballers, with all teams getting the opportunity to play in Faithful Fields. The Jerry Conway and Jack Wyer tournaments then got underway with these finals being held in Glenisk O'Connor Park for Jerry Conway and Ballinamere for the Jack Wyer. Many thanks to all involved for organising successful competitions in memory of their departed club members.

On Facebook alone, we accumulated just under 4 million views, with most posts averaging around 15,000 views. The stand-out post of the year reached an incredible 110,000 people, highlighting the growing interest in our content. This surge in visibility is largely thanks to the exceptional work of Mark Forde, whose innovative approach has significantly boosted our online presence. Video views on Facebook saw a remarkable 93% increase compared to 2023, reflecting our expanding audience and enhanced content strategy. Our live lotto draw, hosted every Thursday, has become a popular feature, consistently attracting viewers as we invite special quests to participate in the draws. Meanwhile, our Instagram page has also seen substantial growth, recording 3.3 million views over the past year, with a top post reaching 99.9k views. On X (formerly Twitter), Offaly GAA has cemented its reputation as a reliable source for real-time updates, scores, and results. With over 42,000 followers, our page remains highly active, especially during weekends, keeping fans engaged and informed. This growth across all platforms reflects Offaly GAA's commitment to connecting with our community and enhancing fan engagement.

### **Programmes / Team Sheets**

This year, we provided programmes for over 300 adult championship and league games in both hurling and football, including all adult and under-age finals. This was a monumental task that required careful planning and coordination. The success of this initiative would not have been possible without the tremendous support from club secretaries across the County, whose collaboration ensured smooth operations. I extend my deepest gratitude to John Hackett and Carina Carroll in the office, whose dedication was instrumental in managing the workload. Additionally, a big thanks to

the Coaching and Games staff and the broader network of volunteers who played a crucial role in the delivery of these programmes to venues throughout the County. Their commitment and hard work were vital in ensuring that every match day was complemented with a programme, enhancing the experience for players, supporters, and everyone involved.

## Coaching & Games - Coiste na nÓg

Offaly GAA's Coaching and Games and Coiste na nÓg play a crucial role in developing young athletes and promoting hurling and football throughout the county. We try to promote this and ensure that all these activities are made visible to our clubs, players and supporters through our social media platforms. The Faithful Óg Academy is a flagship initiative, providing structured coaching pathways for young players, focusing on skill development and fostering a love for the game. This academy not only improves individual skills but also builds a strong pipeline of talent for future Offaly teams. The value of the dedicated coaching and games staff cannot be overstated. Their commitment ensures that children across Offaly have access to high-quality training, nurturing their abilities in a positive and encouraging environment. Their work has seen a significant rise in the volume of children engaging in hurling and football, reinforcing the county's passion for these national games. A special word of thanks is passed on to Carina Carroll and Keith Screeney, whose tireless efforts and dedication have been instrumental in driving these initiatives forward. Their contributions have helped create a vibrant culture of Gaelic games for the youth of Offaly.

## Children's Officer

2024 has been another year of many positives and challenges within Offaly GAA from the Children's Officers' perspective and I would like to start by extending a huge thank you to all those in their clubs who have taken on the role this year. Club officers are to be commended for their continued efforts in ensuring that the guidelines from Croke Park and Offaly GAA are being adhered to and are taking their Child Protection responsibilities seriously, insisting that all who work with our underage players have been vetted, safeguarded, and have received the appropriate level of coaching qualifications.

Again, this year an audit was carried out by Croke Park to assess the risks associated with our underage structures across the country. While these audits can be a little time consuming it served well in highlighting the core areas within our association that need more focus and enables us to provide the best and safest environments for our children, to grow and development their GAA skillset at both National & local level. With all the above taken into consideration Offaly GAA are committed to providing our clubs with all the resources necessary to maintain best practices and standards within our county. It is hoped that in 2025 we will provide even more safeguarding and coaching qualification courses, to meet the needs of clubs. Each year, there are some issues that arise, and all clubs need to be continuously mindful of.

One such issue is that of respect - abusive language both on the field and towards match officials in our games. All clubs should have a zero-tolerance approach in this area and all team mentors and club committees should be aware of the procedures in place to deal with the issue if it arises. We, the adults, need to lead by example so that our young people see that there is no place for this type of behaviour in our National Games. The issue of negative side-line behaviour by coaches has been a real challenge this year with numerous reports of club mentors/coaches acting inappropriately in terms of abusive language within their club roles as team coaches, this is an extreme breach of our code of conduct and clubs needs to address these issues internally. In the current climate where Child Protection is paramount and we hang on hat on providing a safe

environment for children to grow and develop, this is completely unacceptable. The responsibility lies with clubs to ensure that the highest standards of behaviour during games are set and maintained, and that players, coaches and supporters are aware of these and lead in this regard, setting good example.

Sport is intended to be primarily fun and as the adults involved, we need to promote a positive side-line culture. Sport when working with underage players" and the "Guide to Maintaining appropriate levels of behaviour in our work with children and young people". These are available at the Safeguarding course and online at:

Another issue of concern in our current climate is the use and misuse of social media in our clubs & games. While there are many great benefits to the use of these platforms in the day to day running of our clubs, it is important to reinforce that - all GAA members, coaches, mentors and players are subject to a code of conduct when online, even when they are not acting on behalf of the GAA. All members are responsible for their own actions and must be aware that those actions may have consequences for the GAA. We all have a responsibility when using social media platforms not to do anything that might tarnish the GAA's image and reputation or bring the GAA into disrepute. It is paramount that all clubs continue to exercise a duty of care, advise and police the guidelines around the use of social media to protect our most vulnerable.

Finally, as I conclude my five-year tenure with Offaly GAA, I would like to commend the Coiste Na nÓg committee for their extensive games planning over the last year, offering huge opportunities to under-age football & Hurling across the county. I would like to compliment the clubs in continuing to raise their standards in Child Protection and compliance and trust that this will continue into 2025. I would like to thank the executive committee of Offaly GAA for their continued support to me in my role and I wish all club officers all the best as we approach another new year filled with lots of new challenges and opportunities, while we work hard and continue to serve the young players of Offaly GAA.

#### Referee's Courses

All Offaly referees undertook the in-service training course this year, which was completed online. In addition, a number of training seminars took place in the Faithful Fields with a focus on performance enhancement including safeguarding, physical fitness, and video analysis of games played in the previous year's championship, to ensure that referees had a good knowledge of the rules. Thanks to the LOETB for the use of their centres in Tullamore and Birr and use of their instructors.

## **Juvenile and Adult Games**

Youth leagues began in March and concluded with a total of 1541 games which have taken place to date, with 40 referees officiating. With the advancement of the average age profile of referees within the county, it should be a cause for concern for all clubs that our referees are being asked to take part in a games schedule that no player would be expected to perform in. It has been a good season for appointments to games and we wish to offer our sincere thanks to all our officials who have offered their time and often at short notice. The introduction of development leagues have been a great success for our clubs to offer more children the chance to take part in our games and I'm sure we all wish for this to go from strength to strength. With this in mind, it is important that we consider, when planning fixtures, the strain that is placed on the small pool of referees to ensure these games were a success.

All championships have concluded and we wish to thank all match officials for endeavouring to officiate all our championship games to the highest standard. Offaly GAA have become accustomed to all match officials conducting themselves in a professional manner and these standards do not happen by accident. The preparation for championship games is at a high level not just for referees but for sideline officials. Prior to first round of the championship, open meetings were held with club officials and club managers, which was

a twofold scenario where the committee outlined the rules and explained what they expected from the players and management with video clips and new guidelines now in place. Club mangers also had the opportunity to outline their views. This was part of a concerted effort to improve standards.

This season also saw progression at all rounds in the senior championship to have official linesmen.

I would like to acknowledge the clubs who assisted us with linesmen through the year and also to thank the clubs for the facilities at club grounds which have definitely improved throughout 2024 for our referees and his officials.

#### **Recruitment and Advisors**

This season also saw three new referees complete their first season. Over the season there was a new mentoring system put in place with the aim of enhancing referee performance. Three former officials agreed to take on roles of mentoring referees and carried out assessments of serving referees. We would like to thank the officials for their efforts. Overall, the advisory scheme for serving referees seeking feedback and areas to improve on has been a positive activity for referees wishing to engage and develop their ability.

Seventeen clubs in the county are not supplying referees, and this has to improve for 2025.

### **Inter-County Referees**

Over the course of the past season Offaly GAA have up to five referees between Provincial and Leinster panels and we wish them the best of luck with this throughout 2025.

#### **Thanks**

The Competitions Control Committee and Management Committee were also very supportive during the year. Sincere thanks to all members of the Referees' Committee with Brian Gavin as Chairman, Chris Dwyer, Bill Kavanagh (RIP), Brendan Troy, and Declan Ward. # **Health & Wellbeing Committee**

The Irish Life GAA Healthy Club Programme operates off a two-year cycle. Clubs have 18 months to complete the criteria and subsequently achieve Foundation, Silver and Gold Healthy Club status.

Phase 6 is now active and will run until August 2025. Applications to join the programme are now closed and will reopen in Autumn 2025.

Healthy Club Officers involved in the Irish Life GAA Healthy Club programme since Phase 1 (2013) - Phase 6 (2024) can use their unique login details to access the portal and update their club account and reports accordingly. The Healthy Clubs portal is only available to clubs registered with the GAA Community & Health Department.

The following clubs are now accredited as Healthy Clubs: Ballinamere, Ballycommon, Coolderry, Gracefield, Kilcormac/Killoughey, Kilclonfert, Raheen - Foundation Status; Bracknagh, Daingean, Seir Kieran and St Rynaghs Hurling – Silver Status. Other clubs who are participating are Doon, Ballycumber, Ballingar, Shannonbridge and clubs who had participated in the programme were Tubber, Shamrocks, St Rynagh's Football. We are aware that there are a few clubs who are meeting the Healthy club criteria but not registered in the programme we would encourage them to do so. Updating Healthy Club activities has become easier now with the Healthy Club portal, which eliminates reporting through the County Committee.

In 2024 our focus was ensuring that clubs remained informed on how they can become hubs for health information and programmes, thereby helping and enabling their members and communities to enjoy healthier and more inclusive lifestyles, ensuring a healthier future for everyone. One of the key areas we aimed to highlight is how clubs can leverage on and work with partnerships from outside organisations for example Offaly Local Development Company and the HSE which several clubs have already established successfully.

This year there was no GAA Healthy Club Annual Conference. Instead, four regional events took place with the Leinster event held in Clane on 15th October, along with County Health and Wellbeing Committee Forum on Saturday 16th November in Croke Park.

The County HWC committee were represented at two Leinster Provisional Meetings during 2024 (one online) with the final one on September 26th at which the national updates where presented. Updates covered the roll out of the SMOKE FREE and VAPE FREE venues, 147 venues in total - Connacht 23 - Munster 39 - Leinster 54 - Ulster 3. We are in the process of making Glenisk O Connor Park one of the venues for 2025. The Ireland Lights Up Project is due to run as usual in January 2025 but there may be slight change due to removal of Operation Transformation from the RTE schedule.

Finally thank you to all who participated in the Health & Wellbeing structures and supports and to the Offaly County Board for their support during the year.

We would strongly advise any clubs who are not participating in the Healthy Club project to date to consider making an application for inclusion in the next phase which will reopen in August 2025.

# **Offaly Handball**

## Milestone Year

2024 marks a significant milestone in the history of Handball, as it celebrates 100 years of affiliation with the Gaelic Athletic Association. Offaly has always had a strong tradition of handball, producing many great players during this time with the county's commitment to nurturing young talent being a driving force behind its continued growth.

This year, several juvenile players have demonstrated their skills and passion for the sport, competing at county, provincial, and national levels. Also, this year saw a development plan being rolled out across the county with both Crinkle and Fahy Handball Clubs being the driving force behind the initiative in introducing handball to six primary schools. All of this wouldn't have been possible without the help of Offaly Sports Partnership

in providing funding to help us grow the sport. We will start to see the benefits of this scheme next year with the intention of expanding in the years ahead subject to the availability of funds.

We had over 20 children competing in the 40x20 Championships this year with many of the participants contesting both Quarter and Semi-Finals. The players continued to develop and are getting stronger year on year and hopefully before long the county will be contesting provincial and All-Ireland Finals at underage level.

In the 60 x 30 four Offaly players represented the county in the Under 12 and Under 13 B Doubles. Antoni Soswoski and Ryan McNamee put up a strong fight in their semi-final but were narrowly defeated by Kilkenny's Cian Dowling and Jack Mulcahy. In the U12 Doubles, Keelan Grogan and Kajus Martinkevicius showed determination, securing a place in the final, though they ultimately fell short against Kilkenny in a hard-fought match losing 15-10, 15-13.

#### Feile na nGael

A team consisting of Jack Curley, Fionn Kilmurray, Ryan and Tadgh McNamee competed in the Feile na nGael One Wall competition. After coming through their group, they booked a place in the final of the boys' division 2. It wasn't to be their day as they were defeated 21-18, 21-14 by Kilglass, Co. Roscommon.

# Cumann na mBunscol and Secondary Schools Competitions

Offaly had strong representation at provincial level, with twelve players from Crinkill and Ballybryan National Schools representing the county in the Leinster Cumann na mBunscol. Among them, Francis Soswoski, Ryan McNamee, Patrick Guing, Donnacha Connolly, Sennan Kerrigan, Michael Hosey, Emilie DeForge, Emily Enright, Bebhinn Hoctor, Lauren Masterson, Anna Hosey and Aimee Curley competed in the Leinster finals, which were held in Croke Park. The event provided an exciting experience for the children who got to play in Handball HQ and faced off against strong competition from across Leinster in their respective divisions. We reached several semifinals with Ryan McNamee and Michael Hosey losing out in the boy's doubles U13 Leinster final to Dublin, 15–12, 13–15, 11–8.

In the secondary schools competition Michael Hosey and Ryan McNamee represented St. Mary's Edenderry in the First Year Leinster  $60 \times 30$  Championships. They

reached the final and were pitted against St Peter's of Wexford. After a very good run in the competition, they were defeated in two straight games.

#### 60 x 30 Adult Achievements

John Murphy and Kevin Cooke continued their good form in the 60 x 30 format with the duo reaching the Leinster Final of the Over 35's Doubles. A Wexford pairing of Jimmy Goggins and Paddy Berry defeated Offaly in two straight games. Cooke also advanced to the Silver Master B Leinster final. His semi-final victories over Wexford and Dublin set up a showdown with Kilkenny's Brendan Hosey, which he narrowly lost in a tiebreaker after winning the second game, 21–17, 15–21, 11–9.

David Hope and Conor O Brien were unsuccessful in the Master's A Doubles All-Ireland Final when they were defeated by Mayo's Joe McCann and Ollie Cassidy. However, it wasn't all bad news with Hope winning the All-Ireland singles title defeating Galway's Ollie Conway.

Cathal McNamee and Declan Kilmurray played in the Junior doubles. After a first-round win over Westmeath, they were defeated in the Quarter Final by Dublin's Michael Carrie and Rob Farrelly.

Sian Cooke reached the All-Ireland Junior C 60 x 30 final, where she faced Wexford's April Moran. Despite a valiant effort, Cooke lost in two games 21-11, 21-5, with Moran playing exceptional handball throughout match.

### 40 x 20 Adult Achievements

The county's adult players also saw success and strong performances across various championships, both provincially and nationally. David Hope and Conor O' Brien reached the All-Ireland Semi-final of the Masters A 40x20. They were defeated by Cavan brothers Paul and James Brady. In the singles of the same competition, David Hope was runner up in the Leinster Final to Wexford's Gavin Buggy.

John Murphy, representing Offaly in the Men's Junior C singles, had a solid run in the Leinster Championship. After victories over Laois and Wexford, he advanced to the Leinster final, where he faced Ciaran Gallogly of Kildare. Despite playing some excellent handball, John lost in two straight games, 21–17, 21–14.

John partnered with Jack Jones in the Men's Junior C Doubles competition, where the pair showed great resilience, defeating teams from Wexford, Kilkenny, Kildare, and Westmeath to reach the Leinster final. In

a gripping final against Laois, the Offaly duo battled hard, winning the second game but ultimately losing out in a tiebreaker, 21-9, 16-21, 11-2, to Brian and Eamon Brennan.

Jack Kirwan and Kevin Cooke had a good run in the men's Junior B doubles where they advanced to the Leinster Semi-Final. After defeating Carlow, Dublin and Wexford in the opening rounds, they lost out on a place in the final to Kilkenny's Roy Cullen and Conor Condron 21-18, 14-21, 11-9.

#### **Historic All-Ireland Victory**

A landmark achievement for Offaly Handball came in 2024 with the first-ever All-Ireland title won by a female player. Sian Cooke made history by capturing the All-Ireland Junior C 40x20 title in dramatic fashion. After a tough start in the final against Deirbhile O'Neill from Antrim, Sian fought back from a 14-1 deficit to win 21-19. In the second game, she held on to secure a 21-17 win, marking a historic victory for both Crinkle Handball Club and Offaly.

## 2024 World Handball Championships

For the first time in the history of handball the One-Wall and Four-Wall World Championships were held separately. In early August the One-Wall Championship was held in the University of Limerick with over 900 competitors. Offaly players Fionn Kilmurray, Jack Curley, Noel Murphy, Ryan and Tadhg McNamee competed at the Limerick venue. We had a good run with all juveniles winning their first round and Jack Curley reaching the plate Semi-Final. Our best performer was Noel Murphy who partnered with Niall Kerr of Tyrone in the Men's Over 50's Doubles. After some very tough matches, Noel and Niall reached the World Final but had to settle for second place after the favourites Jared Vale and Marc Ciprut defeated them 21-6, 21-6.

In the Four-Wall World Championships, a total of eight players represented their club and county at various venues across Leinster. Our juvenile player Ryan McNamee was defeated in his opening round 15–13, 15–5 by Karl Boland. Cathal McNamee took to the court against Colm Parnell from Ballyhogue but was also defeated in his opening round 15–7, 15–11. David Hope partnered with Pat Conway from Galway in the Men's Over 40's grade. After their Quarter-Final win, they faced Dominic Lynch and Gavin Buggy in their Semi-Final. After a hard-fought contest, they lost out in the tiebreaker 11–5 with Lynch and Buggy progressing to win out this grade.

In the Over 50's, Conor O' Brien and Declan Cooke formed separate partnerships with Kirk Rhys and Michael Carrie. In the opening round of the doubles O' Brien and Rhys played tremendous handball. After losing the first game 15-8, they went on to win the second game 15-8. It would come down to the tiebreaker but unfortunately the Meath brothers Michael and Tom Sheridan won the game on a scoreline of 11-3. After qualifying for the plate competition, Conor and Kirk went on to win the Plate Final 21-15 defeating Graham Casburn and Morgan Duggan. Declan Cooke, in partnership with Michael Carrie gave a great account of themselves but it wasn't to be their day as the pairing of Jared Vale and Joseph Kaplan proved too strong and defeated them 15-10, 15-8.

Jack Jones and John Murphy played in the Men's C singles and partnered together for the doubles. John was defeated in his opening round of the singles, 15-8, 12-15, 11-4 by Kevin O'Callahan of Kilkishen, Clare. Jack won his first round defeating Jason Lieng, New York, USA, 15-5, 15-3 but was later beaten in the next round 15-10, 15-7 by Clare's Darragh Burke. In the doubles John and Jack defeated Carter and Jason Gilmore of Canada 15-8, 15-9. In the second round they were defeated by Adam Kenny and Michael Mullins of Tinryland, Carlow, 15-7, 9-15, 11-6.

Sian Cooke played in the Ladies' C singles and teamed up with Yoshida Kenco of Japan. Sian was defeated in her opening round of the singles by Sarah Walsh, Mallow, Cork, 15-9, 15-11. In the doubles Sian and Yoshida played against Monaghan's Emily and Louise McGinnity. After a great start winning the first game 15-13, they found themselves chasing the second game with the Monaghan team taking that game 15-3. It was all to play for with the Monaghan duo being the favourites to win out this grade. Sian and Yoshida fought hard in the tie breaker and held the lead for most of the game but eventually they lost 11-9 after a great performance.

Sian qualified for both the singles and doubles plate competition and after convincing wins over Eilish Owens of Galway, Frances Byrne, Coolboy, Wicklow, she faced Sinead Forde, Kells, Meath in the final. Both ladies fought hard for every ball, and it was a tough contest but in the end the Meath, lady won it on a score line of 21-14. The doubles saw Sian and Yoshida take on Nuala Dunning and Agnes Hurley of Conna, Cork and after a strong performance and convincing win they faced Anne Marie Ryan and Karen Monaghan, Ballina, Tipperary. The Tipperary duo proved too strong and won the match 21-4.

The event kicked off on Saturday October 26th and ran until November 3rd with a record entry of nearly 1,700 participants competing. Initially, the event was to be hosted by Carlow, Laois, Kilkenny and Croke Park but with such large numbers, extra venues in Kildare, Wexford, Wicklow and Offaly were required. Crinkle was one of the venues selected with the club along with their 22 volunteers being more than willing to help with hosting matches.

Each day of the event the club hosted between 8 and 14 matches with a 9am start. During the day the participants and spectators were treated to the hospitality of volunteers with food and refreshments, with numbers over the course of the day exceeding one hundred people.

Not only did the tournament bring a lot of activity to the club, but it also brought competitors and spectators from across Ireland, England, Canada, Mexico, America and as far away as Japan. This was a boost to the greater area with people staying over for a few days, dining out and visiting some of the local attractions.

2024 has been a remarkable year for Offaly Handball, marked by significant achievements and continued growth. From the inspiring success of young talents like Ryan McNamee to the historic wins of Sian Cooke, the county has shown an unwavering commitment to the sport. As we celebrate 100 years of GAA Handball, Offaly Handball is excited about the future and the potential to build on this momentum.

We are hopeful that Offaly GAA will continue to support the sport financially, enabling us to expand and introduce handball to new areas. The continued dedication of our players, coaches, and supporters ensures that Offaly Handball will remain a vibrant and thriving part of our community for years to come. Here's to the continued growth and success of the sport in Offaly, as we look forward to what lies ahead.

## **COUNTY CONVENTION MOTIONS 2025**

#### **BYE-LAW MOTIONS**

Amend/include the following Bye-Laws (Amendments/Additions highlighted in red)

MOTION No. 1 COUNTY COMMITTEE

## 1. COUNTY CONVENTION (Rules 3.8 to 3.15 T.O.)

**1.1.** County Convention, convened in accordance with Rule 3.8, shall elect/appoint Officers and Representatives in accordance with Rule 3.9 and Delegates in accordance with Rule 3.10 following nomination in accordance with Rule 3.11.

Chairperson, Vice-Chairperson, Secretary, Assistant Secretary, Treasurer, Assistant-Treasurer, Coaching Officer, Officer for Irish Language and Culture, Public Relations Officer and shall appoint a Planning & Training Officer, Demographics Officer and a Children's Officer recommended by the outgoing County Committee.

It shall further elect two representatives on Provincial Council and one representative on Central Council.

- **1.2.** A person nominated for any of the above elected positions shall, 10 days before Convention following a request from the County Secretary, confirm in writing their willingness or otherwise to seek or not seek election.
- **1.3.** Rule 3.9 (b) (2) shall not apply to the office of Treasurer i.e., five-year limit applies.
- **1.4.** Before publication of Convention Motions submitted in accordance with Rule 3.12 these shall be examined by the Management Committee. Motions considered out of order should be returned to the submitting Unit indicating reasons and affording an opportunity to re-submit by a date specified in advance of County Convention.

## 2. COUNTY COMMITTEE (Rules 3.16 to 3.19 T.O.)

- 2.1. The County Committee shall consist of the Officers elected/appointed pursuant to Bye Law No. 1, the two Provincial Council representatives, and the one Central Council representative, (elected pursuant to Bye Law No. 1 above who shall be ex-officio members), one named delegate from each affiliated club, the County Safety and Facilities Officer, Demographics Officer, County Referees' Administrator, the Coiste na nÓg Chairperson, one named representative each from the County Primary Schools Committee, the County Post Primary Schools Committee and the County Handball Committee and the Head of Operations (without voting rights).
- **2.2.** Where a vacancy arises for the position of Honorary President, The County Committee, at the first County Committee meeting of the year, shall elect its Honorary President, following nominations from Clubs. The nominees shall be people who have given service in a voluntary administrative capacity to Offaly GAA. They shall hold office for a term of five years. On completion of their term, they shall become Honorary life Vice Presidents of Offaly GAA.

Their duties shall include representing the County at functions or events if requested by the County Chairperson. The Honorary President may attend at meetings of the County Committee and at County Convention but shall not be entitled to vote. They may, provided they are invited by the Chairperson,

speak at County Committee meetings and/or at County Convention. The Honorary President shall present the Club of The Year Awards at County Convention.

**2.3.** In accordance with Rule 3.18 and subject to Rules 3.19 and 4.1 T.O. the County Committee shall appoint the following sub-committees whose powers and functions shall be as detailed therein and, in these Bye Laws where appropriate. The County Secretary shall retain a current list of members of each sub-committee and circulate to the County Committee. The membership of each shall be determined as follows:

## (i) Management Committee

It shall consist of the Officers elected/appointed at Annual County Convention, the Coiste na nÓg Chairperson, representatives to Central and Provincial Council and the Head of Operations Manager (without voting rights).

In accordance with Rule 3.18(i) a recommendation of the County Management Committee on a matter of Finance may not be upset save by a three-fifths majority of members of the County Committee present, entitled to vote and voting.

## (ii) Competitions Control Committee

It shall consist of a Chairperson, Secretary and two other members, nominated by the Management Committee for appointment by the County Committee, two named nominees of Coiste na nOg, a named representative of the Finance Committee, one Fixtures Analyst together with the County Referees' Administrator (who shall vote only on the appointment of Referees).

#### (iii) Fixtures Analysts

As per Rule 3.18 (iii) T.O.

#### (iv) Hearings Committee

It shall consist of a Chairperson and six other named members (one of whom shall act as Secretary), nominated by the Management Committee for appointment by the County Committee.

## (v) Safety and Facilities Committee

It shall have six members including County Safety and Facilities Officer who shall be Chairperson, a Qualified Event Controller. The remaining members, nominated by the Management Committee for appointment by the County Committee, should be suitably qualified in areas relevant to the terms of reference of the Committee as outlined in Rule 3.18 (v) T.O.

#### (vi) Planning and Training Committee

It shall consist of five members, the Chairperson of which shall be the County Planning and Training Officer. All members shall, upon appointment, complete the necessary training as prescribed by The National Officer Development Committee and Club and County Planning Committee.

## (vii) Referees' Administration Committee

It shall consist of the County Referees' Administrator and five other named members (one of whom shall act as Chairperson and one of whom shall act as Secretary), nominated by the Management Committee for appointment by the County Committee.

## (viii) Coaching and Games Development Committee

It shall consist of the County Coaching Officer, as Chairperson, Head of Games Development (who shall act as Secretary), all full-time employed Games Development Coordinators, and four other named members, one of whom shall be the Hurling Coordinator and one of whom shall be the Football Coordinator, nominated by the Management Committee for appointment by the County

Committee.

#### (ix) Cultural Committee

It shall consist of the Officer for Irish Language & Culture, as Chairperson and four other named members (one of whom shall act as Secretary), nominated by the Management Committee for appointment by the County Committee.

#### (x) Public Relations/Marketing Committee

It shall consist of the County Public Relations Officer, as Chairperson and four other named members (one of whom shall act as Secretary), nominated by the Management Committee for appointment by the County Committee.

#### (xi) Youth Committee

It shall consist of five named members (one of whom shall act as Chairperson and one of whom shall act as Secretary) nominated by the Management Committee for appointment by the County Committee.

## (xii) Finance Sub-Committee

It shall consist of eight named members (one of whom shall act as Chairperson and one of whom shall act as Secretary) nominated by the Management Committee for appointment by the County Committee.

## (xiii) Information Technology Committee

It shall consist of the County Public Relations Officer and three other named members (one of whom shall act as Chairperson and one of whom shall act as Secretary) nominated by the Management Committee for appointment by the County Committee.

## (xiv) County Teams Management and Panels Sub-Committee

The membership of the County Teams' Management and Panels' Committee shall be as outlined in the Charter for County Committee/Player Relationships and as approved by Árd Chomhairle from time to time and shall be nominated by the Management Committee for appointment by the County Committee.

## (xv) Audit & Risk Committee

It shall consist of no more than five named members including a Chairperson nominated by the Management Committee and approved by the Provincial Audit and Risk Committee and up to four members nominated by the Management Committee. The Treasurer shall not be a member.

## (xvi) Demographics Committee

It shall consist of the County Demographics Officer, who shall act as Chairperson and four other named members (one of whom shall act as Secretary), nominated by the Management Committee for appointment by the County Committee.

#### (xvii) Health and Well-Being Committee

It shall consist of the Children's Officer and four other named members (one of whom shall act as Chairperson and one of whom shall act as Secretary), nominated by the Management Committee for appointment by the County Committee.

**2.4.** In accordance with Rule 3.17 (m) T.O. the County Committee shall appoint the following Sub-Committees whose powers and functions shall be as set out in these Bye Laws.

## (i) County Post-Primary Schools Committee

It shall be responsible for the promotion of the aims of Cumann Lúthchleas Gael in all Post-Primary Schools in Offaly through the preservation and promotion of Gaelic Games and pastimes. It shall encourage as wide a participation in Gaelic Games, as is possible. This Committee shall be appointed annually, by the County Committee and shall include a representative of each affiliated Post-Primary School, a representative of the County Coaching and Games Development Committee and an Officer of the County Committee. The County Chairperson shall nominate the Chairperson, for appointment by the County Committee.

## (ii) Coiste na nÓg Committee

It shall be responsible for the promotion of underage club activities, for minor grades and below, shall be controlled by a Sub-Committee of the County Committee to be known as Coiste na nÓg.

- (a) Coiste na nOg shall promote underage club activities, for minor grades and below, except where the County Bye Laws provide otherwise. It shall make recommendations to the Competitions Control Committee for arrangements for all Competitions and/or Championships of underage football and hurling up to and including the Minor grade.
- (b) Coiste na nOg shall consist of Chairperson, Vice-Chairperson and Secretary, who shall be appointed at the first meeting of the County Committee each year following a nomination from the Management Committee. One representative from each of Cumann na mBunscol, County Handball Committee, County Camogie Committee (non-voting), County Ladies Football Committee (non-voting) and one representative from each club's underage sub-committee or where clubs combine to form an Independent Underage team one representative from that team (one representative to represent all underage teams up to and including the Minor grade). The Coaching Officer and Children's Officer elected and appointed respectively at County Convention shall act ex officio on Coiste na nOg.
- (c) Coiste na nOg Chairperson, Vice-Chairperson, Secretary, Coaching Officer and Children's Officer shall be responsible for the day to day running of the affairs of Coiste na nOg.
- (d) Coiste na nOg shall meet as required.

## 3. ATTACHMENT TO FIRST CLUB

**3.1.** In accordance with Rule 6.3 (c) T.O. a person seeking to become a member of the Association shall be restricted to joining a Club in the Catchment area of his permanent residence or where he has other relevant connection with a particular club as defined by 6.2 (b) (i) T.O. A Club Catchment Area shall be defined as within the Parish and within the County boundary, based on the boundary of the Roman Catholic Parish. If a player wishes to become a member of the Association, by joining a club, outside of the catchment area of his permanent residence, he or the club must submit to the County Secretary, his entitlement to do so.

#### Exception.

(a) The above definition of Club Catchment applies except where an existing agreement approved by the County Committee is in place.

## 4. PERMANENT RESIDENCE

**4.1.** Permanent Residence is defined in Rule 6.2 T.O. with the following exception.

#### Exception.

(a) To meet the requirement of permanent residence, a player must be residing at his current address for at least 16 weeks. In such cases the onus of proof of new permanent residence shall be on the applicant. Acceptance of proof of residence shall be at the discretion of the Competitions Control Committee.\_

A utility bill is not acceptable as proof of residence. A Rental Agreement registered with the Residential Tenancies Board is deemed acceptable as proof of residence. In cases that include a move from the principal private residence, proof of disposal of, or rental of, that property shall be required.

## 5. OTHER RELEVANT CONNECTION

**5.1.** Rule 6.2 T.O. sets out criteria considered to constitute 'Other Relevant Connection' with a particular Club.

## 6. TRANSFERS

- 6.1. Transfers within the County shall be dealt with in accordance with Rule 6.4 (a) T.O.
- **6.2.** Applications for transfers, within the county, shall be submitted on a duly completed official transfer application form. All Such applications must be submitted to the County Secretary prior to the first meeting of the County Committee each year, which shall be held in January, and no further applications will be considered after that date.
- **6.3.** Such application shall not be granted unless the player is in permanent residence in the Parish in which his new club is located is opting for his First Club or has "Other Relevant Connection" with a particular Club as defined in sub-section (b) (i) of Rule 6.2. T.O.
- **6.4.** The Competitions Control Committee shall process and make initial decisions on all applications for Transfer and Permission to Play within the county. Such decisions shall reflect the ethos of the Association as outlined in Rule 6.1. T.O. and give due consideration to the negative effect, if any, it may have on the player's First club.

## 7. CLUB TEAM GRADINGS

- **7.1.** No club may have more than one team at each grade.
- **7.2.** A club that wins any grade of championship shall have that team graded at the next highest level for the following year. A club that loses a relegation final (as outlined in Championship regulations) shall have that team graded at the next lowest level for the following year.

## **Exceptions.**

- (a) If a club that wins a Championship, already has a team in the next highest grade, that team cannot be graded at the next highest level for the following year. In this instance, the team that loses a relegation final, at the next highest grade will not be regraded for that year only.
- (b) If a club loses the relegation final of a particular grade and has a team at the next lower level, no relegation will take place from the higher grade for that year only.
- (c) Clubs entering teams in the Junior A, B or C, Championships may apply to the CCC for for a change of grade, within Junior level.
- **7.3.** Requests for grading of teams in (c) above shall be accepted by the CCC, not less than 10 days prior to the first County Committee Meeting of the year. No other request for grading shall be accepted. The CCC shall make a recommendation in relation to any such applications to the County Committee. The County Committee retains the right to make the final decision on an application for grading by a Club.

## 8. PLAYER GRADINGS

- **8.1.** On a date specified by the CCC, a Club may apply to have players regraded by one level, subject to the Club retaining a minimum of fifteen players, approved by the Competitions Control Committee, in each of the required grades, at the Championship status level of the previous year, other than where a Club has been relegated from a Championship.
- **8.2.** A player may not be regraded by more than one level.

#### Exception.

- (a) Players who played on the winning team in Senior B, Intermediate or Junior championship finals shall be considered to be of Senior, Senior B or Intermediate status respectively for the following year's championships, unless they have been regraded.
- (b) Clubs impacted by Offaly Bye Law 7.2 (a) & (b) may submit an exceptional player regrading application to the Competitions Control Committee as per Code (10.8).
- **8.3.** In Accordance with Code 10.8 (b) a player aggrieved by a decision on his application for Regrading shall have the right of appeal to the County Hearings Committee whose decision shall be final.

## 9. AFFILIATION

**9.1.** In accordance with Code 4.3 (C) entry fee for Championship shall be €80 for each adult team and €8 for each under-age team.

## 10. PLAYING RESTRICTIONS (Rule 6.7 T.O.)

**10.1.** Subject to the Exceptions hereunder and Bye Law 3.1 Exception (a), the Parish Rule shall be in force for all grades.

## **Exceptions.**

(a) In accordance with Rule 3.17 (o) and Rule 6.7 T.O., Exception (1) (a) or (b): Where there is no under-age team in a Parish (including Minor & U20), a player in that Parish, may play with an Independent Team within the County which shall not bear the name of an adult Club within the County.

Or

- (b) With another Under 21 or Younger Grade Team within the County. In the case of a team having five or more players under this provision in Rule, the team shall play under and be recognised by the combined names of the Clubs in question or by an independent name which shall not bear the name of an Adult Club within the County.
- (c) Where a player has been granted such permission, in previous years, and a team is formed, in a club or Independent team within his Parish, that player must play with that club or Independent team.
- (d) A Player, who's club is not part of an Independent Team, may not be granted permission to play in a higher age grade than he is currently eligible for e.g. A player who is eligible to play at U13 in the current championship year, may not be given permission to play at U15 level with another club or Independent team.
- (e) In accordance with Rule 6.7 (c) T.O. where there is no adult football team in a Parish, a player from a hurling Club, in that Parish, may play with a football team, and vice versa, within the County. Acceptance of such a request shall be at the discretion of the Competitions Control Committee.
- **10.2.** Applications for Exceptions in **10.1** above shall be processed by the County Competitions Control Committee and approved by the County Committee each year. All applications for Exceptions shall, be submitted, on duly completed application forms, to the Committee, by the relevant Club Secretary seven clear days (168 Hours) in advance of the 1st meeting of the County Committee each year.

When considering such applications the CCC shall consider the playing numbers, in that grade, of the club or Independent team, the player wishes to play for. The CCC may recommend the application not be granted if, it is the view of the CCC that, there are sufficient players in that club or Independent team. In such instances the CCC may recommend playing with an alternative nearby club or Independent team.

Exceptions shall only be approved where all players, at the same grade, from a club are going to the same Club/Independent Team.

#### Exception.

- (a) In exceptional circumstances, the CCC may consider an application outside the timeframe specified in 10.2 above, for an individual under-age player (up to and including U17) during the regular playing season.
- **10.3.** Applications for Independent teams shall only be accepted, on an annual basis, for a team formed in accordance with and complying with the Central Council Policy for the Regulation of Independent Teams.
- **10.4.** If a Club or Independent Team fields an ineligible player, the player and club officials shall be subject to the penalties outlined in the codes and rules of the Official Guide. For the avoidance of doubt the officials concerned shall be the Chairperson and Secretary of each club that forms an Independent Team.

Notes to the Financial Statements for the year ended 30 September 2024

#### 1. General Information

Offaly County Committee is a sports organisation in which the registered office and principal place of operation is O'Connor Park, Arden Road, Tullamore Co. Offaly. The organisation is responsible for the development and oversight of Gaelic games in Offaly.

## **Statement of Compliance**

The County Board's financial statements have been prepared on a going concern basis and in accordance with accounting standards issued by the Financial Reporting Council.

The County Board's financial statements comply with Financial Reporting Standard 102, the Financial Reporting standard applicable in the UK and the Republic of Ireland (FRS 102).

#### Currency

The financial statements have been presented in Euro (€) which is also the functional currency of the Association in Ireland.

#### 2. Accounting Policies

Basis of preparation of financial statements:

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates.

It also requires management to exercise judgment in applying the organisation's accounting policies.

#### Going concern

The entity financial statements have been prepared on a going concern basis.

In assessing going concern management has considered budgets and forecasts for the foreseeable future and the impact of severe but plausible downside scenarios.

Management is satisfied that the use of the going concern basis is appropriate.

#### Foreign currency translation

Transactions in foreign currencies are recorded at the rate ruling at the date of the transaction.

Monetary assets and liabilities denominated in foreign currencies are retranslated at the rate of exchange ruling at the financial year end date.

Non-monetary items that are measured at historical cost are translated at the foreign exchange rate ruling at the date of the transaction.

Non-monetary items measured at fair value are translated at the rate of exchange at the date of the valuation.

All foreign exchange differences are taken to the Statement of Income and Retained Earnings.

## **Government and Other Grants**

Grants are accounted under the accruals model as permitted by FRS 102. Government Grants relating to expenditure on tangible fixed assets are credited to the Income and Expenditure Account at the same rate as the depreciation on the assets to which the grant relates. The deferred element of the grant is included in creditors as deferred income.

Grants of a revenue nature are recognised in the Statement of Comprehensive Income in the same period as the related expenditure.

Notes to the Financial Statements for the year ended 30 September 2024

#### Revenue recognition

Revenue is derived from gate receipts, Sponsorship, Leinster and Central Council contributions, affiliations fees, entry fees and fundraising activities.

Income is recognised when it is capable of reliable measurement and the principal risks and rewards of ownership have passed to the organisation.

Income from gate receipts and fundraising activities is recognised on the date of the activity.

Income from sponsorship, Leinster and Central Council contributions, and affiliationfees are recognised in accordance with the individual agreements.

#### **Financial instruments**

The organisation only enters into basic financial instrument transactions that result in the recognition of financial assets and liabilities like trade and other debtors and creditors, loans from banks and other third parties, loans to related parties and investments in ordinary shares.

#### **Borrowing costs**

All borrowing costs are recognised in the income and expenditure account in the year in which they are incurred.

#### **Tangible fixed assets**

Tangible fixed assets under the cost model are stated at historical cost less accumulated depreciation and any accumulated impairment losses.

Historical cost includes expenditure that is directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.

Depreciation is charged so as to allocate the cost of assets less their residual value over their estimated useful lives.

Depreciation is provided on the following basis: Office Buildings 20% straight line

Equipment 20% reducing balance

New Stand 2% straight line

The assets' residual values, useful lives and depreciation methods are reviewed, and adjusted prospectively if appropriate, or if there is an indication of a significant change since the last reporting date.

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised in the income and expenditure account.

#### **Debtors**

Short term debtors are measured at transaction price, less any impairment. Loans receivable are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method, less any impairment.

Notes to the Financial Statements for the year ended 30 September 2024

#### Cash

Cash is represented by cash in hand and deposits with financial institutions repayable without penalty.

#### Creditors

Short term creditors are measured at the transaction price. Other financial liabilities, including bank loans, are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method.

#### **Provisions for liabilities**

Provisions are made where an event has taken place that gives the organisation a legal or constructive obligation that probably requires settlement by a transfer of economic benefit, and a reliable estimate can be made of the amount of the obligation.

Provisions are charged as an expense to Income and Expenditure account in the year that the organisation becomes aware of the obligation, and are measured at the best estimate at the Statement of financial position date of the expenditure required to settle the obligation, taking into account relevant risks and uncertainties.

When payments are eventually made, they are charged to the provision carried in the Statement of financial position.

#### 3. Judgement in applying accounting policies and key sources of estimation uncertainty

The officers consider the accounting estimates and assumptions below to be its critical accounting estimates and judgements:

#### Useful life of tangible fixed assets

Long-lived assets represent a significant portion of total assets. The annual depreciation charge depends primarily on the estimated lives of each type of asset and, in certain circumstances, estimates of residual values.

The Management Committee regularly review these useful lives and change them if necessary to reflect current conditions.

In determining these useful lives the committee members consider physical condition and expected economic utilisation of the assets. Changes in the useful lives can have a significant impact on the depreciation charge for the financial year.

The net book value of Tangible Fixed Assets subject to depreciation at the financial year end date was €8,772,039 (2023 €9,037,616)

#### Allowance for impairment of debtors

The County Board estimates the allowance for doubtful trade debtors based on an assessment of specific accounts where the Management Committee has objective evidence comprising default in payment terms or significant financial difficulty that certain customers are unable to meet their financial obligations.

In these cases, judgement used is based on the best available facts and circumstances including but not limited to, the length of the relationship.

#### **Accruals**

The organisation has accruals recorded in the Statement of Financial Position and this is reviewed monthly by the organisation.

Estimates on the accruals is based on the most reliable evidence at the time the estimates are made.

These estimates take into consideration the cost or income directly relating to events occurring subsequent to the reporting date to the extent that such events confirm conditions existing at the end of the reporting period.

Notes to the Financial Statements for the year ended 30 September 2024

#### **Prepayments**

The organisation has prepayments recorded in the Balance Sheet and this is reviewed monthly by the organisation.

Estimates on the prepayments is based on the most reliable evidence at the time the estimates are made.

These estimates take into consideration the cost or income directly relating to events occurring subsequent to the reporting date to the extent that such events confirm conditions existing at the end of the reporting period.

#### 4. Provisions Avaliable for Audit of Small Entities

In common with many other entities of our size and nature, we use our auditors to assist with the preparation of the financial statements.
